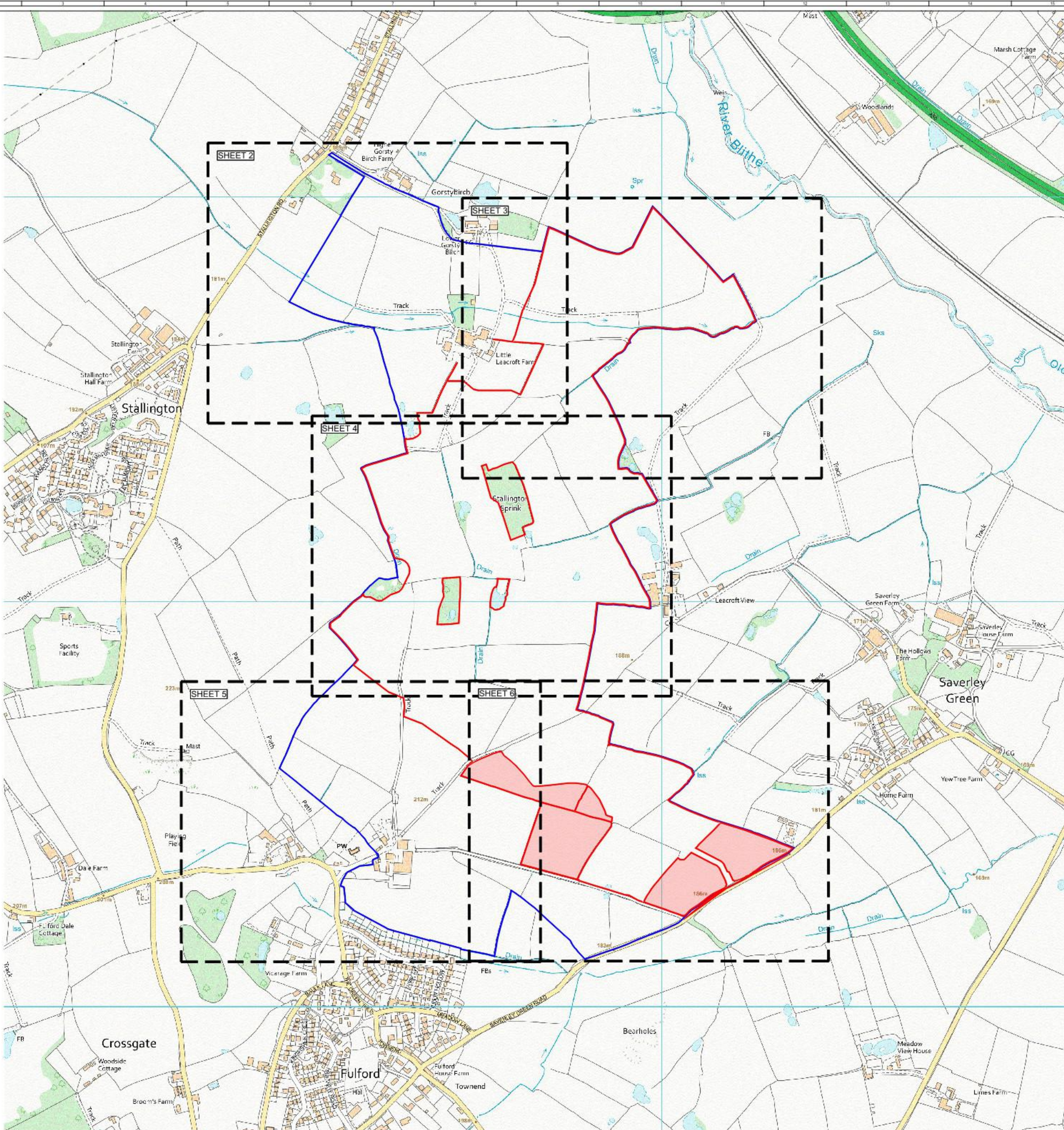

Location Map (05004-RES-LAY-DR-PT-003)**

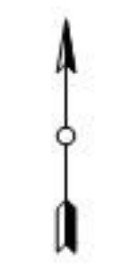

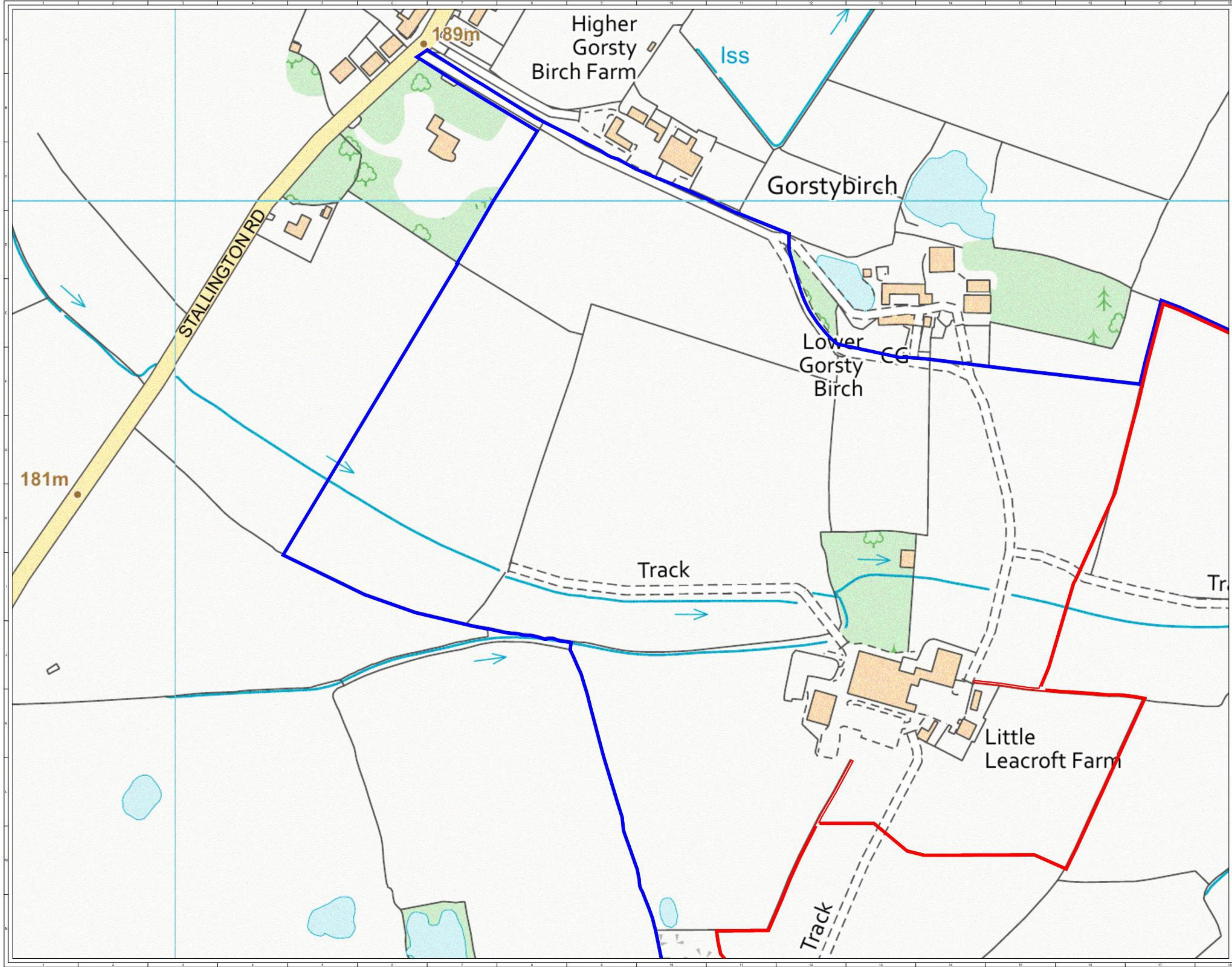

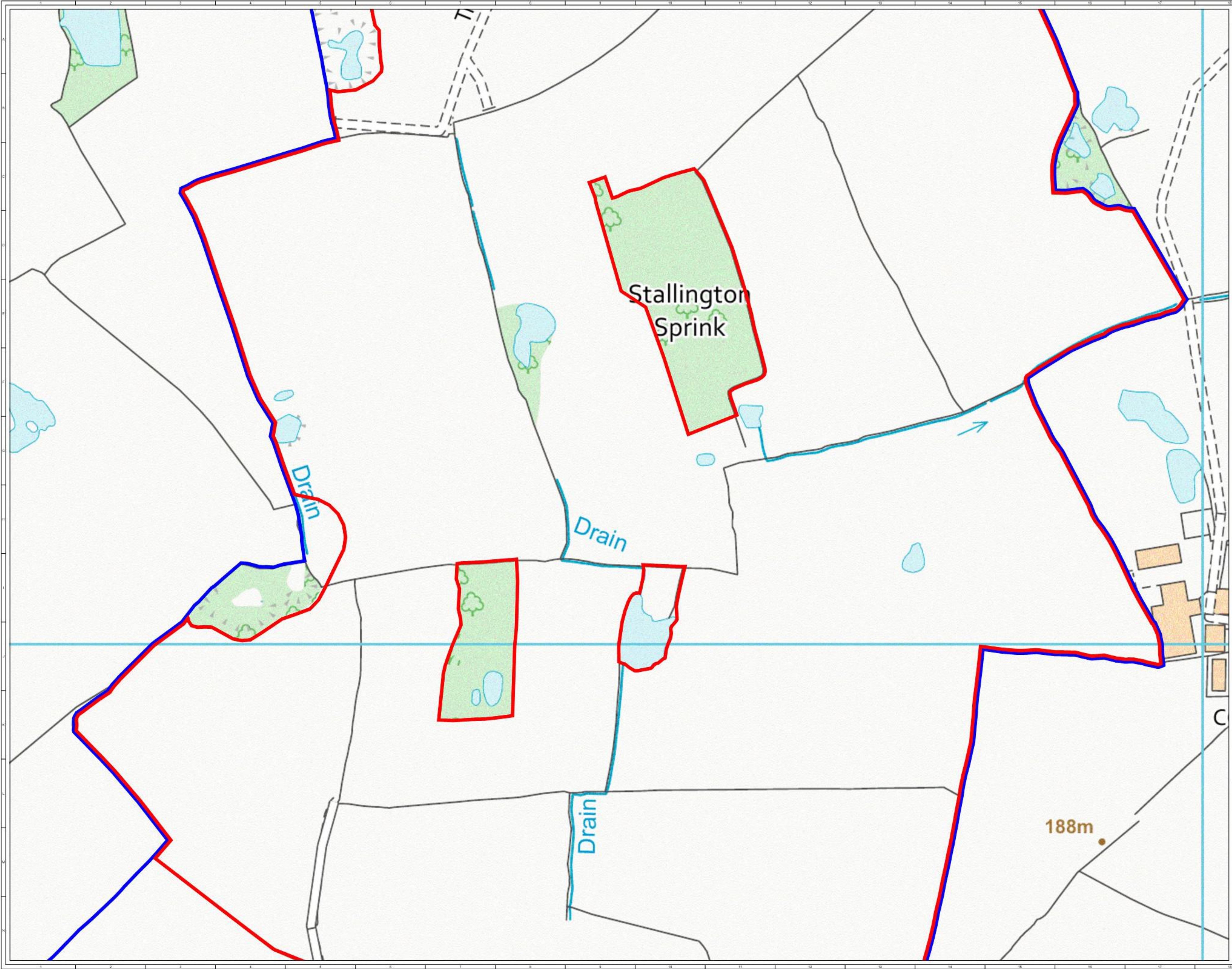
